A tax rate of \$0.1139 per \$100 valuation has been proposed by the governing body of Hidalgo County Drainage District #1.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Hidalgo County Drainage District #1 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Hidalgo County Drainage District #1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Hidalgo County Drainage District #1 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 19, 2023 AT 9:30 AM AT HIDALGO COUNTY COMMISSIONER COURT ADMINISTRATION BLDG 100 E. CANO EDINBURG TX 78539.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Hidalgo County Drainage District #1 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of Hidalgo County Drainage District #1 at their offices or by attending the public hearing mentioned above.
