The purpose of this public meeting is to:



PROJECT PURPOSE AND NEED



What are we trying to do?

Project Purpose

Provide drainage relief to a natural low area impacted by flooding in previous rain events.

The scope of work includes the expansion of an existing drainage system.

The design is based on a 50year flood, using Atlas 14, the most current rainfall date.

What are the issues? Project Need


Within the last few of years, Hidalgo County has encountered more frequent and intense storm events, which have resulted in widespread floods.

The drainage system was originally designed to drain agricultural areas based on a 10-year flood and does not have sufficient capacity.





PROJECT INFORMATION




The project location and limits are between Mile 9 North, Mile 15 North, FM 493, and the IBWC Floodway, containing approximately 18,600 acres just north of the City of Weslaco, Texas.

- Funded through Hidalgo County Drainage District No. 1 2018 Drainage Bond Program and TWBD Flood Infrastructure Fund
- Changes to TWDB application required an update to the environmental review process






DRAINAGE STUDY EXISTING CONDITION







PROPOSED IMPROVEMENTS




